Reason for the pesticide application: Stinging Insect Activity

Description of the possible adverse effects of the pesticides as per the Material Safety Data Sheets for the pesticides to be used, if available: (PI Contact) Primary routes of exposure: Routes of entry for solids and liquids include eye and skin contact, ingestion, and inhalation. Routes of entry for gases include inhalation and eye contact. Skin contact may be a route of entry for liquefied gases. Acute toxicity: Relatively nontoxic after single ingestion. Slightly toxic after short-term skin contact. Relatively nontoxic after short-term inhalation. Irritation / corrosion: May cause slight irritation to the eyes. May cause slight irritation to the skin. (Tempo 1% Dust) Harmful if swallowed. Causes eye irritation.

**Pesticide product label instructions and precautions related to Public Safety.** EXTREMELY FLAMMABLE. KEEP OUT OF REACH OF CHILDREN. KEEP OUT OF REACH OF DOMESTIC ANIMALS. HARMFUL IF ABSORBED THROUGH SKIN. Avoid contact with the skin, eyes, and clothing. Wash thoroughly after handling.

Aerosol container contains flammable gas under pressure. (Tempo 1% Dust) Wash thoroughly after handling. Do not eat, drink, or smoke when using this product.

**REMEMBER:** Whenever a non-low impact pesticide is used on school property there is also a Restricted Entry Interval (REI) that begins when the pesticide application ends. This Restricted Entry Interval last for seven hours unless the product label uses NUMERIC LANGUAGE, e.g., 4 hours or 12 hours; directing a longer or shorter period of time for Restricted Entry. If the product label does not discuss Restricted Entry the period of time defaults to seven (7) hours.
